State Resources

ICCB Illinois Community College Board

As the state coordinating board for the Illinois Community College System, ICCB is responsible for administering the Public Community College Act, statewide planning and coordination of the community college system, administering state and federal grants to community college districts and adult education providers, managing high school equivalency testing for Illinois, collecting and maintaining enrollment, completion, and student characteristic information on community college students, and coordinating Illinois Community College System data collection, administrative data matching, and reporting.



ICCB

ICCB's website is the first stop for information about ICCB and the Illinois Community College System, like a Community College Directory, district maps, a Directory of Programs, data and reports, ICCB System Rules and policies and ICCB division specific information. ISBE Illinois State Board Education

ISBE administers secondary education in the state of Illinois by establishing policies and guidelines for public and private schools from preschool through grade 12. ISBE is designated as Illinois' eligible agency for the federal Perkins V grant. ISBE delegates authority to ICCB to administer, operate, and supervise postsecondary Perkins V grant activities. ICCB and ISBE work closely to administer Perkins in the state.
